LCA strives to educate the public about animal cruelty and exploitation through websites, brochures, email alerts, mailings and newsletters. All of these educational tools are valuable resources for the public as they contain information on a variety of animal rights issues, encourage readers to take action and provide an opportunity to update members about LCA activities.

LCA's newsletter, "Fighting Chance," reaches 150,000 members and the main website ([www.LCAanimal.org](http://www.LCAanimal.org)) receives over 300,000 hits a month. LCA's e-mail action alerts ask for "Calls to Action" from members about issues needing urgent attention. Members are e-mailed information and asked to make a phone call or to write a fax or letter to help bring about needed changes for animals.

LCA's founder and president, Chris DeRose, is frequently interviewed for television and radio programs, newspapers and magazines, nationally and internationally. He also travels both in the U.S. and abroad, giving lectures and educating the public about animal rights. Countless people have read or heard about LCA and Chris DeRose through the 40-50 interviews in 2015.

Locally, LCA and the Animal News Van (ANV), attends special events, conferences, schools and fundraisers. LCA's custom-made, donated ANV is equipped with two large plasma televisions screens, a speaker system and led ticker tape. The ANV uses the

powerful medium of video to educate citizens about the current conditions animals live in by showing investigative reports and disseminating breaking news stories. Special emphasis is given to schools, educating students and encouraging them to adopt a compassionate, cruelty-free lifestyle. Attendees at each event range from 30-300.

In March 2015, LCA successfully defeated Arkansas bill HB 1774, which would have banned audio recording between anyone in an employment relationship unless all parties consented. After LCA exposed the bill to the media and circulated a petition against it, HB 1774 died quietly in committee. Ag gag is freedom-crushing state legislation aimed at punishing whistleblowers on factory farms. Ag gag laws are in clear violation of First Amendment rights, and negatively affect humans in addition to animals. These dangerous laws allow food safety risks, employee harassment, and unsafe working conditions to go unreported. The recent surge of ag gag bills is in response to a series of highly publicized undercover investigations by animal activists and journalists. These investigations have led to criminal convictions, lawsuit and major food recalls, and have allowed consumers to see the hidden practices of agribusiness. Because of the economic damages these investigations have caused, the agriculture lobby has relentlessly been pushed ag gag bills through state legislatures. LCA continues to monitor ag gag bills and fight against them as they arise.

In 2015, LCA was heavily involved in the campaign to end horse drawn carriages in New York City (NYC). Forced to work nine hours a day, seven days a week in extreme weather conditions, the horses live a dismal nose-to-tailpipe existence until they are "retired" and sold off at auction - and often sent to Mexico or Canada for

slaughter. LCA's undercover investigators documented the sad reality that NYC horses endure every day, and revealed horses deprived of food and water, made to pull carriages while obviously in pain, and tethered so tightly in their stalls at night they could not lie down. LCA's campaign included billboards in NYC that were aimed at New York's City Council urging them to pass Intro 573 banning horse-drawn carriages and bus stop posters in key districts to target specific council members. LCA also aired a PSA on major cable news networks, including CNN, Fox News and MSNBC - throughout the five boroughs of NYC urging citizens to contact their council members to support the ban. The carriage industry isn't just cruel; it threatens the safety of New Yorkers and tourist alike. LCA continues to work on protecting the horses and people of New York City until a ban on horse-drawn carriages is passed.

## Description of Program Service Two

## Investigations:

Last Chance for Animals (LCA), often referred to as the "FBI of Animal Rights," is widely known for its Special Investigation Unit (SIU) that conducts in-depth investigations to expose horrible cruelty and misuse of animals. The SIU team focuses on validating information, detecting suspect activity, exposing illegal or unethical activities and reporting them to local, state and federal authorities for prosecution. The information obtained in LCA's investigations is used to develop campaigns, provide grassroots education and outreach to the public, and to help in drafting legislation that will bring lasting changes for the animals. The scope of LCA's investigations includes, but is not limited to: pet theft, class "B" dealers,

puppy mills, pound seizure, circus cruelty, elephants in captivity, animals used in entertainment, vivisection and pharmaceuticals manufactured from the demise of animals.

LCA's Special Investigation Unit has a full-time team in China since May of 2015 documenting and providing undercover footage of the dog meat industry. LCA's campaign, [www.StopDogMeat.com](http://www.StopDogMeat.com) is focused on ending the dog meat trade and the annual Yulin Dog Meat Festival. Every year, an estimated 10 million dogs are killed for their meat in China. The dogs are trucked long distances in cramped wire cages before they are tortured, beaten, boiled or skinned alive. LCA's undercover investigation team continues to document and expose China's dog meat industry and provide information to authorities to get the slaughterhouses shut down. The information is also being used to provide support to get legislation passed in China that will outlaw the dog meat industry.

In May 2015, the findings of LCA's undercover investigation into Pel-Freez, the largest rabbit slaughterhouse in the United States was released. Undercover footage documented the horrific abuse and barbaric slaughter process that involved breaking live rabbits' legs and slicing their throats. After completing the investigation, LCA submitted a criminal complaint to the Benton County Prosecutors Office detailing 323 instances where conscious rabbits experienced intentional infliction of a major physical trauma, and 193 instances where rabbits were experiencing pain and distress, all overseen by plant managers and many times witnessed by USDA inspectors. The slaughter process was changed at Pel-Freez, rabbits are no longer being killed while conscious, due to the findings of LCA's investigation. LCA's campaign, [www.RabbitCruelty.com](http://www.RabbitCruelty.com), conducted protests and targeted online petitions that were

successful in getting major supermarkets such as Gelson's and Harris Teeter to stop carrying Pel-Freez rabbit meat.

In December 2015, the U.S. Congress passed a ban of all funding of USDA Class B licenses for dealers selling "random source" dogs and cats to medical research. This will effectively shut down Class B dealers, who will be unable to renew their licenses in 2016. This victory follows more than 35 years of investigations, prosecutions and campaigns against Class B dealers by LCA. In October 2014, the National Health Institute of Health (NIH), the largest funder of biomedical research in the US, announced they stopped funding research that involved dogs obtained from USDA licensed Class B dealers. LCA has played a leading role in the investigation, prosecution and conviction of USDA licensed Class B dealers, who provide "random source dogs" (often stolen pets) to research facilities for cruel and invasive experiments. Class B dealers are known for the horrible abuses they inflict on the animals and the filthy conditions they are kept in. This NIH ban follows a similar ban involving cats from Class B dealers which was adopted in 2012. In 2003, LCA concluded a 15-year investigation into B dealers and handed the case over to the U.S. Attorney's office which prompted the United States Department of Agriculture (USDA) to charge the largest and most notorious dealer with more than 100 violations of the animal welfare act. This was the first time a U.S. Attorney's office took on an animal rights case. LCA's SIU undercover operations obtained 70 hours of footage and proof of horrendous abuse at the B dealer's property. In 2005, the same dealer was fined the largest fine ever imposed by the USDA and his license was permanently revoked. In 2006, civil and criminal charges were settled against the B dealer. This precedent setting case is a big win for the animals and has set case law. Due to this Federal felony conviction, this B dealer can no longer vote, bear arms, have

any dealing with animals in any way and must report to a probation officer. LCA's harrowing investigation into this class B dealer was the subject of HBO's America Undercover 2006 documentary, "Dealing Dogs". Hundreds of dog dealers have been put out of business or quit in large part due to LCA's work. LCA will continue to campaign against the use of live animals in scientific experimentations.
